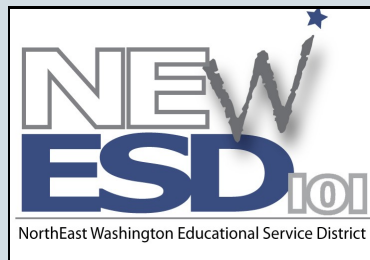

What we are/what we do: The Northeast Washington Education Council (NEWEC) is a tax-exempt 501(c)(3) foundation. NEWEC receives, manages and distributes income and gifts supporting the educational mission of Spokane-based NEWESD 101.

NEWESD 101 serves 59 public school districts and 47 state-approved private schools enrolling 95,026 students (May 2010) in grades pre-K through 12.



NEWEC service area: Adams, Ferry, Lincoln, Pend Oreille, Spokane, Stevens and Whitman counties.

NEWEC mission: The foundation serves the region on many levels: as an applicant for grants serving the region's schools; as an "umbrella" foundation for school districts that do not operate their own foundations; and as a recipient of cash and gifts earmarked for educational services.

NEWEC services: Specific areas of focus include programs serving at-risk youth; staff development for local educators; scholarships; and partnerships between business and education.
