OSPI Early Numeracy Professional Development

OSPI, in collaboration with ESD partners from around the state, has created three early numeracy professional development modules: Counting and Cardinality Operations, Algebraic Thinking and Geometry. This three-day series is geared toward preschool through second grade teachers and will be delivered through two full-day workshops. Participants will be given resources and activities to implement in classrooms in between workshops and will have opportunities to share learning and ideas with job alike professionals.

- 2. Operations and Algebraic Thinking** - Learn what research tells us about how young children learn mathematics and what we need to teach in order to prepare students for early operations. Engage in hands on activities that increase student understanding and can be replicated in the classroom.

The Importance of Caring for Ourselves: Managing the Impact of Vicarious Trauma

In this day and age when schools are facing the reality of violence, the need for our own health and wellness is critical. If we the professional, aren't healthy, then how can we be effective for our students and families? Trauma is real, and it is more prevalent than we might believe. In this engaging, relevant, and practical session, learn from childhood trauma expert Kristin Souers (lead author of best-selling and award winning *Fostering Resilient Learners: Strategies for creating a trauma-sensitive classroom* – ASCD, 2016) about the importance of self-care practices in the professional setting. We will focus on how to manage the impact of vicarious trauma as well we explore strategies on how to manage the stress of our jobs. Together we will identify ways to build on community and strength within ourselves, our buildings, our districts and our region.

Objectives:

1. We will explore strategies to utilize with children and our colleagues with (known and unknown) trauma histories – helping to sustain learning-ready (and teaching-ready) states.
2. We will collaborate and refine our plans to implement #TraumaSensitive approaches and mindsets in our buildings in order to support adults and our students in a strengths-based manner.
3. Participants will reflect on how this information impacts their role and their overall health, collecting suggestions for self-care and self-awareness.

Participants will review the cycle of risk management and response. This process includes a large focus on prevention strategies as well as de-escalation techniques. Post-crisis follow-up is a necessary task of risk management and response. The ethical consideration and use of physical interventions is also taught for use as a last resort in order to maintain safety. The focus of this workshop will be on avoiding the need for the use of physical safety techniques in order to manage risk safely and effectively. Participants completing this course will receive a two-year recertification.

Prerequisite: Current Right Response Elements Certification or not more than 3 months expired. If certification is more than 3 months expired participant must complete a RIGHT RESPONSE Elements workshop to recertify. Regular recertification is important for ensuring a consistent level of quality conduct and minimize liability exposure.

Disclaimer: If original certification was obtained outside of NEWESD 101, a copy of your certificate of completion will be required, prior to attending this class, in order to verify that you are within the 3 month window of renewal.

Agencies who choose to recertify staff do so for the following reasons: 1) Meets policy requirements. 2) Quality Assurance (which is equally important when staff intervene regularly, or rarely). 3) Protects employers by demonstrating proactive approach to defining staff conduct expectations.
